9. Review Water Conservation Plan; approve annual report and water conservation implementation report on implementation of Water Conservation Plan; adopt Order Adopting Amended and Restated Water Conservation Plan.
10. Update on preparation of bond application.
11. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement or solicitation of bids, review bids and award contracts, approve letter financing agreements, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. surface water, chloramine conversion, and bleach disinfection conversion;
 - b. Cypress North Houston Road (LouEdd Road) widening;
 - c. feasibility studies, plan reviews, and utility availability requests;
 - d. Cypress Glen sanitary sewer repair project;
 - e. updates to Emergency Preparedness Plan and Emergency Response Plan;
